

NOTES

FOR VESSELS THAT, DUE TO THE EXISTENCE OF OVERDUE UNPAID CLAIMS OWED TO THE MARINA, ARE PLACED IN A DRY BERTH UNDER THE “ONSHORE FOR DEBT“ PROVISION, THE DAILY DRY BERTH RATE SHALL BE INCREASED BY 100% PER DAY (THIS APPLIES TO ALL VESSELS IN MARINA VERUDA). THE MARINA RESERVES THE RIGHT NOT TO HAUL A VESSEL IF THERE ARE NO AVAILABLE MEANS OR SPACE ON LAND. CARAVAN TRAILERS ARE FORBIDDEN TO ENTRY INTO THE MARINA AREA AND TO USE OF ELECTRICITY CONNECTIONS.

THE AREA AROUND DOCK 18 IS SHALLOW, PLEASE TAKE CARE WHEN ENTERING AND EXITING THE MARINA - MARINA VERUDA SHALL NOT BE LIABLE FOR ANY DAMAGE.

DISCOUNTS

LOYALTY DISCOUNTS FOR YEARLY BERTHS, PROVIDED THAT THE PAYMENT IS MADE FOR 12 MONTHS IN ADVANCE:
FROM 2 TO 4 YEARS 3%, FROM 5 TO 9 YEARS 5%, FROM 10 TO 14 YEARS 7%, MORE THAN 15 YEARS 10%.
LOYALTY DISCOUNTS ARE NOT GRANTED FOR VESSELS REGISTERED FOR COMMERCIAL USE AND VESSELS AT NON-COMMERCIAL BERTHS.

NOTE: THE LOYALTY DISCOUNT APPLIES EXCLUSIVELY TO THE OWNER WITH AN OPEN-ENDED CONTRACT.

GENERAL TERMS AND CONDITIONS AND THE RULES OF CONDUCT IN THE MARINA

I. GENERAL PROVISIONS
The provisions of the Marina Price List and these general conditions apply to all berth users, boat users, boat owners and all other persons who, for any reason, are in the area of Marina Veruda. By entering the premises of Marina Veruda, all provisions of these general terms and conditions, the Marina Price List, the Rulebook on maintaining order in the nautical tourism port, the Rulebook on the disposal of all types of waste, the Plan for the reception and handling of waste and cargo residues from vessels, the Regulations and acts relating to the handling of dangerous substances, General Terms and Conditions, corresponding General Terms and Conditions of the berthing contract in Marina Veruda (permanent yearly berth, permanent yearly berth for charter vessels, transit berth) and all internal acts of the Marina that regulate business, stay and behaviour in the area of Marina Veruda are considered to be accepted and applied. These acts are published on the website or on the notice board of the reception, and can be obtained for inspection in other ways, for example by e-mail, inspection at the reception, receiving a written copy or similar. For the purposes of interpreting these general conditions, the term ‘vessel user’ refers to the berth user, the vessel owner and all persons who actually and effectively use the vessel.

II. OTHER

The Marina assigns vessels to berths according to its own discretion, the berthing plan and the Rulebook on maintaining order in the nautical tourism port. The Marina may at

any time, at its own discretion, move the vessel to another suitable berth within Marina Veruda, without warning or approval from the vessel user.
While inside Marina Veruda, the vessel user is obliged to take full care of the vessel and is responsible for all damage that occurs on the vessel and in connection with the vessel, and for all damage to other vessels, the shore, devices, structures, facilities, any object, facility and/or equipment owned by the Marina or a third party.
The user of the vessel is obliged to maintain adequate valid insurance coverage at all times for damage to the vessel's hull, machinery and equipment (CASCO), as well as for damages that could occur to third parties on all grounds related to that vessel (liability insurance). Adequate insurance coverage means the usual Causality and Collision insurance, mandatory liability insurance of the owner/user of the vessel in accordance with relevant legal regulations, and voluntary liability insurance of the owner/user of the vessel for damages that the vessel may cause to third parties. Every boat user must have valid boat insurance for all damages caused to other boats, people or the Marina. The Marina is entitled to establish special terms and conditions for special vessels that require special treatment.
The vessel user is obliged to report their arrival to the marine service or to the reception of the Marina without delay and to immediately submit to the reception of the Marina the valid documents of the vessel necessary for the conclusion of the berthing agreement in Marina Veruda in accordance with the General Conditions of berthing in Marina Veruda applicable to that vessel (e.g. original or a certified copy of valid vessel documents, a valid mandatory vessel insurance policy, a document that shows the ownership of the vessel, a document proving the legal basis of the vessel's ownership, valid personal documents, for vessels under a foreign flag, a license to sail in Croatian waters, a list of persons onboard and everything else required). The Marina reserves the right to request additional documents or certificates that it deems necessary or appropriate in a particular case, and the vessel user is obliged to submit them immediately.
The vessel user is obliged to notify the reception of the Marina in a timely manner every time they leave Marina Veruda. If the vessel has a berth rental agreement in place, the vessel user is obliged to report to the Marina every absence of the vessel longer than one day, and the return must be announced at least 24 hours in advance.
Before departure, the vessel user is obliged to pay in full for all services used according to the valid Marina Price List.
The Marina has the right to retain the vessel with all belongings, parts of the vessel and belongings of the vessel user until full settlement of all claims of the Marina.
In the case of overdue unpaid claims of the Marina on any basis, the Marina has the right to lift or move the vessel to a dry berth under the “onshore for debt” provision at the expense of the vessel user until all debts are settled in full.
For vessels at a dry berth that are under the “onshore for debt” provision, the daily dry berth rate will be increased by 100% per day. If the vessel leaves the Marina by land, all requests for hauling the vessel and loading it for transportation are made through the Marina reception.
The Marina may freely use the berth or assign it to accommodate another vessel while a vessel is out of the Marina. For the interpretation of the provisions of these general conditions and the Marina Price List, the only valid and authoritative text is the Croatian language (regardless of possible translations into other languages). Marina is not responsible for possible deviations in the text in the Croatian language and translation into other languages, as well as possible typographical errors. In the event of a dispute, only documents in the Croatian language will be used.

						NOTES <ul style="list-style-type: none">• A1 Note listed below A: The annual wet berth is valid for all vessels at all wet and dry berths.• The guest needs to define which of our services they want to use. Subsequent modification is not possible.• For catamarans, the price of wet berth, use of crane, hull washing and dry berth increases by 100%. It is not possible to use the dry berth in the period from 01.04 to 30.09. (except with the exceptional approval of the Marina).• For trimarans, the price of wet berth increases by 100%, and for use of crane, hull washing and dry berth by 150%.• Reservations are made exclusively after paying for the service.• For all categories of wet and dry berths, the Marina reserves the right to charge the entire reservation fee in case of non-arrival or early departure of the vessel. It is not possible to change the reserved date after payment.• For all categories of wet and dry berths the price includes: use of sanitary facilities, standard electricity consumption (16A socket), water consumption (does not include washing the vessel), one parking space per vessel.• For annual, monthly and daily wet and dry berths, the location is not fixed.					

A: ANNUAL WET BERTH

A1- Note - Valid for all categories of dry and wet berths. Prices will be calculated based on the vessel's overall (maximum) length and beam, including all equipment and all extensions, all bow extensions, anchors, stern platforms, bathing platforms, supports for auxiliary vessels, footbridges and the like. The Marina has the right to measure each vessel and determine the length and beam in order to determine the berth price. For vessels that belong to a certain category in terms of length but exceed that category in width, the price shall be calculated according to a higher price category.

A2 - Note

For charter vessels outside the charter area (docks 11 – 17) and without a multi-annual contract, the berth price will be increased by 10%.

A3 - Note

For guests with berth contracts the first three (3) days of dry berth service are free once a year (non-commercial berth and the right side of dock 18 cannot exercise this right).

B: SUPPLEMENT FOR DRY WINTER STORAGE

Applies exclusively to users of the annual wet berth (non-commercial berth and the right side of dock 18

cannot exercise this right).

Location on dry land from 01/10 at the earliest to 30/04 at the latest (the following year or within that period). Hauling and launching (once), hull washing (once), vessel transport on land. The supplement for dry winter storage can only be requested in writing through the reception.

C: MONTHLY WET BERTH

Not possible to use in the period from 01/05 to 01/09 (except with the approval of the Marina).

D: DAILY WET BERTH

Valid until 2 p.m. on the last paid day, otherwise

an additional day will be charged.

E: HAULING AND LAUNCHING

One operation
For trimarans, the crane price increases by 150%. Staying on the crane slings up to 1h = 1 operation, longer than 1h = 2 operations.
Vessel towing is charged separately.

F: HULL WASHING INCLUDES:

Washing the hull of the vessel with pressurized water. Only in designated areas by an authorized employee of the Marina.
Hull washing rate shall be increased by 100% for

vessels covered in barnacles.

G: ANNUAL DRY BERTH INCLUDES:

One hauling and launching.
One hull washing.
One transport of the vessel on land.
50% discount on the wet berth daily rate.
Use of the crane cannot be transferred or used the following year.

H: SIX-MONTH DRY BERTH

50% discount on the wet berth daily rate (for the paid period).

I: MONTHLY DRY BERTH

Does not include any additional services.

J: DAILY DRY BERTH

Every day spent on land is calculated: Saturdays, Sundays, holidays and non-working days, regardless of the working hours of the crane.
