

**NOTE:**

FOR VESSELS PLACED ASHORE DUE TO A DEBT, THE DAILY DRY BERTH RATE SHALL BE INCREASED BY 100 %.

THE MARINA RESERVES THE RIGHT NOT TO HAUL OUT THE VESSEL, IF THERE ARE NO AVAILABLE MEANS OR SPACE ON LAND.

THE HULL WASHING RATE SHALL BE INCREASED BY 100% FOR VESSELS COVERED WITH SHELLS.

FOR RESERVATION OF A DRY BERTH ON THE DRY DOCK EXCLUSIVE, AT LATEST UNTIL 30/09 OF THE CURRENT YEAR, THE RATE OF THE SERVICES (D, I and J) SHALL BE INCREASED BY 10% FOR GUESTS THAT HAVE A BERTH RENTAL AGREEMENT AND BY 25% FOR OTHER MARINA GUESTS.

AROUND THE DOCK 18 THERE IS A SHALLOW, SO PLEASE SAIL WITH DUE CARE WHEN ENTERING AND DEPARTURING THE PORT & THE MARINA SHALL NOT BE LIABLE FOR ANY DAMAGE.

**THE GENERAL TERMS AND CONDITIONS AND THE RULES OF CONDUCT IN THE MARINA****I. GENERAL PROVISIONS**

These terms and conditions apply to all recreational craft owners as well as other people present within the Marina area. The general terms and conditions displayed at the entrance gate and on the Marina's notice board are deemed to be accepted by entering the Marina area.

These terms and conditions apply to all recreational craft owners and users as well as other people present within the Marina area on any grounds. All the provisions hereof, the Rules for the maintenance of order in the Marina as well as the provisions of other official documents of the Marina, which are displayed at the entrance gate, on the notice board and in the Reception area, are deemed to be accepted by entering the Marina area.

For the purpose of interpretation of these Rules, the term "recreational craft user" means the recreational craft owner and any other people who are actually using the vessel, regardless if they are the vessel's owner, an attorney of the owner or they are just using the vessel on any other legal basis. This also applies to all people who are using the vessel without the knowledge of the owner and to all people who are using the vessel without the owner's consent.

All provisions of the Rules for the maintenance of order in the Marina, the General Terms and Conditions of the Marina and other official documents of the Marina apply to all recreational craft users.

**II. MISCELLANEOUS**

The Marina assigns vessels to berths according to its berthing plan and the decision of the Marina Management. Subject to modifications to said plan, i.e. according to the decision of the Marina Management, the vessel may be reassigned to another berth.

The recreational craft user is obliged to take care of the vessel moored at the Marina and he/she is liable for any damage caused to other vessels, the shore, machines, devices, appliances, any facility or equipment owned by the Marina or a third party, which are located within the area under the supervision of the Marina. The recreational craft user must at any time be in possession of a valid general third party liability insurance.

Every recreational craft user must be in possession of a valid vessel insurance for all damages caused to other vessels, people or the Marina.

The Marina is entitled to establish special terms and conditions for special vessels that require special treatment.

A vessel is deemed to have been delivered after filling out and signing the contract and the checklist and after handing out the vessel keys at the reception. The Marina is not liable for vessels that have not been properly delivered as described above.

The recreational craft user is obliged to check in without delay at the mooring personnel's office or at the Marina Reception and to immediately produce at the Marina Reception valid vessel's certificates (the original or a certified copy of the certificate of registry/registration card, a proof of current vessel insurance, a document that proves the ownership of the vessel (Certificate of Registration or authenticated registration card), a valid passport or a valid personal identity card, and for foreign flag vessels also a permit for navigation in Croatian waters and the passenger list).

The recreational craft user is obliged to timely notify the reception of the Marina of every departure from port.

If the vessel has a berth rental agreement in place, the recreational craft user is obliged to report to the Marina every absence of the vessel longer than one day. He also has to announce the return of the vessel at least 24 hours in advance.

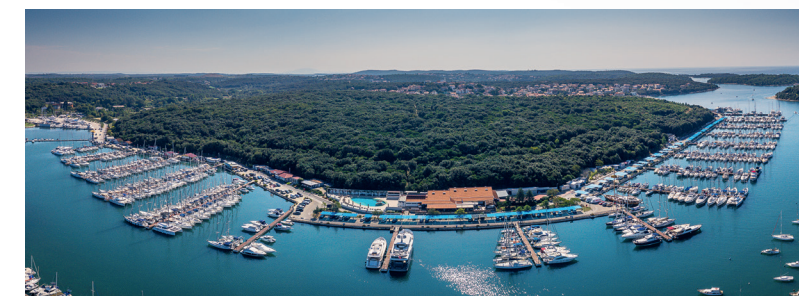
Before leaving the Marina, the recreational craft user is obliged to pay for all the services that he/she made use of according to the current price list. The Marina is entitled to keep the possession of the vessel or the user's belongings until he/she clears all the debts.

In the case of departure from the Marina by land, all activities in relation to the lifting of the vessel and its loading on the trailer will be carried out through the Marina reception.

During the vessel's absence, the Marina may rent the berth to another user.

### SPECIAL REMARKS

**A & B:** The length and width measurements refers to the vessel's maximum overall length and beam.

- Vessels with a length of a whole number of meters (e.g.: 7.00) will be classified in the next category.
- A 100% surcharge will be applied to the wet berth price for vessels with a beam greater than the average (catamarans, trimarans).
- For charter vessels outside the charter area (docks 12 – 17) and without a multiannual contract, the berth price will be increased by 10%.
- For vessels with a beam greater than the average (catamarans, trimarans), the price for the use of crane, hull washing and dry berth without a wet berth will be increased by 150%.

**THE ANNUAL BERTH IS CHARGED FROM THE DATE OF THE WRITTEN BOOKING OF THE BERTH.**

### C: The annual wet berth includes:

- wet berth
- use of sanitary facilities
- use of fresh water
- use of electricity for illumination
- one parking space per vessel

### D: The supplement for winter storage on land includes:

- dry berth from 01/10 through 30/04
- hauling and launching (once), hull washing
- transport of the vessel on land

### E & F: The daily/monthly wet berth includes:

- The marina doesn't guarantee the same berth during the whole stay
- use of sanitary facilities
- use of fresh water
- use of electricity for illumination
- the vessel owner should leave the Marina until 2 p.m. next day, otherwise he/she will be charged for another day
- one parking space per vessel

### G: The hauling/launching rate includes:

### H: The hull washing includes:

- water jet hull cleaning
- the hull washing rate shall be increased by 100% for vessels covered with shells
- only in a designated area signed as such and only by authorised personnel

### I: The annual dry berth includes:

- hauling and launching, hull washing, vessel towing
- use of sanitary facilities
- use of fresh water
- use of electricity for illumination
- one parking space per vessel
- 50% discount on the wet berth daily rate

### J: The six-month dry berth includes:

- use of sanitary facilities
- use of fresh water
- use of electricity for illumination
- one parking space per vessel, vessel towing
- 50% discount on the wet berth daily rate

### K & L: The daily/monthly dry berth includes:

- dry berth without a wet berth
- use of sanitary facilities
- use of fresh water
- use of electricity for illumination
- 10% discount on the dry berth daily rate if the vessel disposes of its own cradle
- one parking space per vessel
